Export Performance of India's Textile and Clothing (T&C)

Products

1.0 Introduction:

As per the DGCI&S data, the export of Textile and Clothing products during the period April-December of 2016 declined by 3.61% to USD 26,916.14 million against USD 27,923.25 million during the same period for 2015. In rupee terms, there is a negative growth of 0.14% from Rs. 1,80,897.64 crore to Rs. 1,80,652.46 crore. It is important to note that about 54% of the export of India belongs to Textiles and 46% Clothing. Details may be seen at Annexure-I.

The export of textile products during the period Apr-Dec' 2016 declined by 6.47% to USD 14,498.95 million as against USD 15,502.67 million during the same period for 2015. In rupee terms, there is a negative growth of 3.11% from Rs. 1,00,432.30 crore to Rs. 97,312.32 crore.

Similarly the export of Clothing products during the period Apr-Dec' 2016 has also declined by 0.03% to USD 12417.18 million against USD 12420.58 million during the same period for 2015. In rupee terms, there is a growth of 3.57% from Rs. 80,465.34 crore to Rs. 83,340.14 crore.

2. Product-wise data is as under:

1.1 Export Performance of Textile Products

- 1. Cotton Fabrics, made-ups etc:** Export value of cotton fabrics, made-ups etc, was USD 3833.66 million during Apr-Dec' 2016 (Rs. 25,730.29 crore) showing negative growth of 3.21% in dollar terms whereas positive growth of 0.28% in rupee terms as compared to corresponding period last year.
- 2. Manmade yarn, fabrics, made-ups:** Export value of manmade yarn, fabrics, made-ups etc, was USD 3314.47 million during Apr-Dec' 2016 (Rs. 22,245.66 crore) showing negative growth of 6.70% in dollar terms (-3.34% in rupee terms) as compared to corresponding period last year.
- 3. Cotton Yarn:** Export value of cotton yarn was USD 2369.38 million during Apr-Dec' 2016 (Rs. 15,902.53 crore) showing negative growth of 14.11% in

dollar terms (-11.02% in rupee terms) as compared to corresponding period last year. Export in quantity terms has also gone down from 9.87 lakh MT to 8.72 lakh MT (-11.65%).

- 4. Handcrafts (Excl. Handmade carpets):** Export value of handcrafts (excl. handmade carpets) was USD 1458.78 million during Apr-Dec' 2016 (Rs. 9,790.87 crore) showing positive growth of 18.98% in dollar terms (23.26% in rupee terms) as compared to corresponding period last year.
- 5. Carpet (Excl. Silk) Handmade:** Export value of carpet (excl. silk) was USD 1093.97 million during Apr-Dec' 2016 (Rs. 7,342.39 crore) showing positive growth of 0.84% in dollar terms (4.48% in rupee terms) as compared to corresponding period last year. Export in quantity terms has also shown positive growth from 752.29 lakh Sqm to 789.23 lakh Sqm (4.91%).
- 6. Cotton Raw including Waste:** Export value of cotton raw including waste was USD 822.40 million during Apr-Dec' 2016 (Rs. 5519.68 crore) showing negative growth of 39.54% in dollar terms (-37.36% in rupee terms) as compared to corresponding period last year. Export in quantity terms has also declined from 9.32 lakh MT to 5.25 lakh MT (-43.62%). The average unit value realization is marginally higher than the previous year.
- 7. Manmade staple fibre:** Export value of manmade staple fibre was USD 434.90 million during Apr-Dec' 2016 (Rs. 2,918.89 crore) showing positive growth of 9.16% in dollar terms (13.09% in rupee terms) as compared to corresponding period last year. Export in quantity has also shown positive growth from 2760.27 lakh kg to 3044.81 lakh kg (10.31%).
- 8. Other textiles yarn, fabric made-ups article:** Export value of other textiles yarn, fabric made-ups article was USD 265.14 million during Apr-Dec' 2016 (Rs. 1,779.52 crore) showing positive growth of 3.55% in dollar terms (7.28% in rupee terms) as compared to corresponding period last year.
- 9. Handloom products:** Export value of handloom products was USD 262.45 million during Apr-Dec' 2016 (Rs. 1,761.50 crore) showing negative growth of 7.43% in dollar terms (-4.10% in rupee terms) as compared to corresponding period last year.
- 10. Coir and Coir manufactures:** Export value of coir and coir manufactures was USD 214.38 million during Apr-Dec' 2016 (Rs. 1,438.83 crore) showing positive growth of 24.30% in dollar terms (28.78% in rupee terms) as compared to corresponding period last year.

- 11. Woolen yarn, fabrics, made-ups:** Export value of woolen yarn, fabrics, made-ups etc, was USD 124.87 million during Apr-Dec' 2016 (Rs. 838.10 crore) showing negative growth of 15.01% in dollar terms (-11.95% in rupee terms) as compared to corresponding period last year.
- 12. Jute Hessian:** Export value of jute hessian was USD 102.99 million during Apr-Dec' 2016 (Rs. 691.26 crore) showing positive growth of 19.08% in dollar terms (23.37% in rupee terms) as compared to corresponding period last year.

Rest of the products whose export is less than 100 millions USD are enclosed in Annexure-II.

1.2 Export Performance of Clothing Products

- 1. RMG Cotton Incl. Accessories:** Export value of cotton RMG incl. accessories was USD 6125.91 million during Apr-Dec' 2016 (Rs. 41,115.15 crore) showing negative growth of 6.72% in dollar terms (-3.36% in rupee terms) as compared to corresponding period last year.
- 2. RMG Manmade:** Export value of manmade RMG was USD 3498.92 million during Apr-Dec' 2016 (Rs. 23,483.65 crore) showing positive growth of 14.45% in dollar terms (18.58% in rupee terms) as compared to corresponding period last year.
- 3. RMG of other textiles material:** Export value of other textiles material RMG was USD 2490.03 million during Apr-Dec' 2016 (Rs. 16,712.29 crore) showing positive growth of 4.88% in dollar terms (8.66% in rupee terms) as compared to corresponding period last year.
- 4. RMG Wool:** Export value of wool RMG was USD 173.65 million during Apr-Dec' 2016 (Rs. 1,165.50 crore) showing negative growth of 22.76% in dollar terms (-19.98% in rupee terms) as compared to corresponding period last year.
- 5. RMG Silk:** Export value of silk RMG was USD 128.66 million during Apr-Dec' 2016 (Rs. 863.54 crore) showing negative growth of 34.78% in dollar terms (-32.43% in rupee terms) as compared to corresponding period last year.

- 1. Other Jute Manufactures:** Export value of other jute manufactures was USD 94.87 million during Apr-Dec' 2016 (Rs. 636.71 crore) showing positive growth of 10.35% in dollar terms (14.33% in rupee terms) as compared to corresponding period last year.
- 2. Natural Silk yarn, fabrics, made-ups:** Export value of natural silk yarn, fabrics, made-ups etc, was USD 48.06 million during Apr-Dec' 2016 (Rs. 322.59 crore) showing negative growth of 27.47% in dollar terms (-24.86% in rupee terms) as compared to corresponding period last year.
- 3. Floor Covering of Jute:** Export value of floor covering of jute was USD 28.22 million during Apr-Dec' 2016 (Rs. 189.41 crore) showing positive growth of 10.58% in dollar terms (14.56% in rupee terms) as compared to corresponding period last year. Export in quantity terms has shown negative growth from 40.35 lakh Sqm to 40.14 lakh Sqm (-0.52%).
- 4. Silk waste:** Export value of silk waste was USD 11.61 million during Apr-Dec' 2016 (Rs. 77.92 crore) showing positive growth of 11.59% in dollar terms (15.61% in rupee terms) as compared to corresponding period last year. Export in quantity terms has also shown positive growth from 11.25 lakh kg to 15.29 lakh kg (35.88%).
- 5. Jute Raw:** Export value of jute raw was USD 8.03 million during Apr-Dec' 2016 (Rs. 53.86 crore) showing negative growth of 14.12% in dollar terms (-11.03% in rupee terms) as compared to corresponding period last year. Export in quantity terms has also declined from 15330 MT to 12130 MT (-20.87%).
- 6. Jute Yarn:** Export value of jute yarn was USD 6.49 million during Apr-Dec' 2016 (Rs. 43.56 crore) showing negative growth of 58.01% in dollar terms (-56.50% in rupee terms) as compared to corresponding period last year. Export in quantity terms has also gone down from 14722 MT to 5423 MT (-63.16%).
- 7. Silk Carpet:** Export value of silk carpet was USD 3.96 million during Apr-Dec' 2016 (Rs. 26.57 crore) showing positive growth of 89.28% in dollar terms (96.10% in rupee terms) as compared to corresponding period last year. Export in quantity terms has shown negative growth from 20390 Sqm to 18400 Sqm (-9.76%).

8. **Wool Raw:** Export value of wool raw was USD 0.25 million during Apr-Dec' 2016 (Rs. 170.14 lakh) showing negative growth of 34.93% in dollar terms (-32.58% in rupee terms) as compared to p corresponding period last year. Export in quantity terms has shown positive growth from 70241 kg to 104990 kg (49.47%).
9. **Silk Raw:** Export value of silk raw was USD 0.07 million during Apr-Dec' 2016 (Rs. 43.93 lakh) showing negative growth of 68.80% in dollar terms (-67.68% in rupee terms) as compared to corresponding period last year. Export in quantity terms has also gone down from 7747 kg to 5534 kg (-28.57%).
